Reference is made to your letter of 18 June 2018 regarding the captioned cases and to Ms. Errani's letter requesting the interpretation of the relevant award.

In this respect, we think that the CAS Panel's resolution to set the starting date on 8 June 2018 is completely legitimate and cannot be amended.

In this regard, at § 212 of the Award the Panel clearly explained the reasoning at the basis of its decision, also taking into account that Ms. Errani regularly played from October 2017 onwards and, therefore, she was able to significantly rise in the ranking.

In the light of above, NADO Italia deems that the Panel's decision is not a matter for interpretation and the award cannot be amended.
